What does this mean?

It is a look of respect earned by your hard work. I cannot thank you enough for your efforts. If you have not taken part in this event in past years, I highly recommend you consider it this year.

Spring and summer of 1974 brought about several changes within Chenango County and the Amateur Radio communications network forming to hopefully provide Emergency Communications locally as well as inter-county capabilities. Guilford man heads emergency radio group 9/22/74

GUILFORD—Marvin Druskoff, K2VIV, Guilford RDI, has been selected to lead an organization of Chenango County amateur radio operators prepared to furnish organized emergency communications in time of disasters. It was announced today by Communications Manager George Hart of the American Radio Relay League, U.S. and Canadian association of radio amateurs.

Mr. Druskoff's assignment, which carries the title of Emergency Coordinator of the Amateur Radio Emergency Corps, is to band together members of the amateur radio service in his community to perfect arrangements for emergency radio communication by hams in the event of natural disasters or other emergencies.

In addition to use of fixed radio station equipment working from commercial power, amateur stations use self-powered radio transmitting and receiving equipment as needed and can often deploy portable and mobile units to accommodate a particular emergency requirement.

Mr. Druskoff as ARRL Emergency Coordinator, will call local meetings of amateurs, establish common operating procedures, and arrange regular drill periods when the hams' personal stations may be mobilized under simulated emergency conditions.

His duties also include liaison planning with relief and public welfare agencies, as suggested in working understandings the ARRL Amateur Radio Emergency Corps has with the Red Cross, Civil Defense, and other agencies. Liaison will be established also with local protective services, such as fire and police departments.

In announcing the appointment, Hart pointed out that radio amateurs have traditionally had the responsibility of being in constant readiness to offer assistance in time of need with ham-acquired skill, emergency-powered transmitters and a wealth of community spirit.

"When sleet storms disrupt telephone and telegraph service, or floods isolate whole communities," the League's Communications Manager said, "it is amateur radio that comes to the rescue with operators and self-powered equipment, often as the sole agency able to transmit messages calling on the outside world for aid for the stricken community."

"To be prepared for this function required not only a highly organized program of preparedness locally," Hart continued, "but hams outside the disaster area must be prepared to act as outlets and relay points for emergency traffic. Planning and organization are necessary in either eventually and that is the job Mr. Druskoff is doing for this area."

'Big Four' test disaster plans 11/21/74

"Operation Big Four", believed to be the most extensive natural disaster exercise ever conducted in Central New York, is expected to test civil defense operations in a four-county area Thursday evening.

The "big four" counties of Chenango, Delaware, Otsego and Schoharie, along with their associated hospitals, will participate in the full-scale natural disaster field training exercise.

The disaster: a mock windstorm. With funnel clouds and heavy rains causing some 200 casualties, the exercise should provide a test of hospital emergency operations and procedures for coping with a wide-scale emergency.

All Natural Disaster and Civil Defense (ND-CD) service centers in the four counties along with volunteers will participate in the mission.

For purposes of mapping Operation Big Four, it will be assumed that a windstorm of large proportions, accompanied by winds with a velocity of 65 miles an hour, hit the four-county area at about 5:30 p.m.

One funnel cloud will have touched down in the area north and east of the City of Norwich, resulting in widespread damage, and two inches of rain will have fallen during the exercise.

Considerable damage will be assumed to power lines, homes, barns, highways and the like, and 200 casualties in the four counties hit by the storm will require first aid, transportation and hospitalization. Thirty of the casualties will be Chenango County people who for purposes of the exercise will be

provided by the various individual fire service emergency squads.

For the exercise in Chenango County, 10 casualties each from the City of Norwich, South New Berlin and Sherburne will be simulated.

The exercise is being coordinated through the N.Y. State Eastern District ND-CD control center in Oneonta, and will be overseen by Enoch Glisene, coordinator, and Joseph P. Durkin, assistant coordinator of the New York University, School of Continuing Education.

During the exercise, all emergency services, centers, equipment and volunteers will be operational. Rescue and ambulance services will be activated in order to provide first aid and transportation from disaster scene to hospital, or between hospitals.

Radio communications for the exercise will be established beginning at 6 p.m., including the newly-created Chenango County Amateur Radio Emergency Corps (AREC). Chenango Memorial Hospital will communicate by way of radio on frequencies and channels normally used in conjunction with the fire service.

Chenango County ND-CD Director Robert G. Prindle said that total involvement of the local emergency organization and all local governmental agencies is anticipated.

The director said that Operation Big Four will be the first time in the history of natural disaster operations in Central New York State that such an extensive operation has been planned.

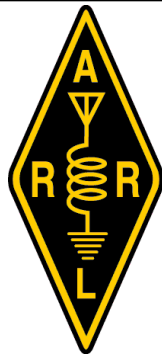
