# Chapter 27

# Welcome To - November 2024

For most of us, the mid 1980s to the mid 1990s saw continuing changes and downsizing in the electronics industry and unfortunately for many of us, the companies we worked for. In amateur radio it was the decade of no-code and computerized everything.

Packet radio was entering the hobby's mainstream, virtually all new radios were completely solid-state and everything was getting smaller and smaller. Amateur radio equipment was also becoming too complex for the average ham to troubleshoot and repair, let alone design and build. Unfortunately, the traditional ham radio hobby of builders and tinkerers was quickly being replaced by a hobby of communicators. And those communications skills would be called on time and time again in the years to follow.

**1985** - PRB-1 was adopted by the FCC - Said the FCC has preeminence in regulating antenna installations, and that state and local ordinances affecting antenna construction would have to comply with FCC regulations.

1985 – Hams gained access to two new WARC bands – 24 Mhz and 902 Mhz. In the same action the FCC made permanent the ham authorization on 10 Mhz. Additionally, this year the FCC authorized the use of Mode L (uplink on 1269.05–1269.85 Mhz) for satellite communications and authorized FAX and TV transmissions on 160 meters.

What were some events and or projects realized by CVARA during this decade?

January 1986 - Received ARRL re-affiliation

Resolved coordinated Repeater Frequency problems

Special Event station at Red Cross "Undisaster Day" with Gil, KA2NKD and Tom, KI2Y as acting net control and logger during this exercise.

February 1986 - Announced 1st VE exam of the year scheduled for April 19.

March 1986 - New Novice to the fold - KA2ZYW - Thomas P. Livingston.

April 1986 - New Club Officers - CVARA supports March of Dimes "Walk-A-Thon."

May 1986 - The old "Newsletter" becomes the new "Bull Thistle Bugle" - Hams support Chenango County with Operation "S.O.B.E.R." and participates In the Clinton Canoe Regatta.

**June 1986** – Hams attend Skywarn meeting in Binghamton – KI2Y appointed Chenango County E.C. – Skywarn activated by severe weather watch – Field Day activity a success.

**July 1986** - Hams toured Link Field Control Tower and Weather Radar Station - New Club T-shirts - New DX column in the "Bugle" - Subscribing to ARN Service - First ARES meeting a success - New Packet Committee organized.

**August** 1986 – Severe Weather Watch activated; – New ARES Telephone Tree distributed – ARES membership total 21

**September 1986** - Club held picnic at Gen. Clinton Park - Skywarn Training program - ARES participated in operation "EMO '86" supporting Chenango County

October 1986 - ARES telephone tree activated.

November 1986 - ARES SET conducted with WA2EYH-7 on Air; Packet demo at county EOC.

Then during **1987**, the FCC proposed "privatizing" the issuance of some call signs. The "on–again, off again" proposal took on several forms, with the last version being the private issuance of club calls. (The proposal was ultimately withdrawn by the FCC in 1993, when it introduced a still–pending plan to issue "vanity" calls.

1988 reported a few silent keys – General Loren G. Windom, W8GZ, who developed the antenna named after him – Bob Henry, W0ARA, of Henry Radio – and Ambassador Bill Porter, who was U.S. Ambassador when Israel became a nation and later was a U.S. Ambassador to Vietnam. During the latter assignment Porter held the call XV5AA.

Here's an interesting note – Gus Browning, W4BPO, noted Dxer and Dxpeditioner became a silent key. Before the days of the keyboard and computerized logging, Gus taught himself

how to write with his left hand so that he could simultaneously send with one hand and write with the other - multi-tasking at its finest!!

**1989** the last of the WARC-79 bands, 17 meters, became available in January. – The ARRL celebrated its 75<sup>th</sup> anniversary. Amid growing calls for a code-free, entry level amateur radio license, and signs that the FCC intended to create one with or without the ARRL's cooperation, the League appointed a committee to study the feasibility. Later in the year, the ARRL petitioned the FCC for a code-free license. Back to the table

1990, the beginning of the year saw a major operation from Bouvet Island (3Y5X). While thousands of hams made contact with the Dxpedition, hundreds caused interference to the operation and 240 U.S. Hams were cited for out-of-band phone operation. The "success" of the operation was treated to mixed reviews in the amateur radio community.

By the end of the year, hams were participating in Operation Desert Shield through MARS operations with the military in the mid-east. Yes, several CVARA members were involved with this operation and as I recall, well over 120 messages were collected, processed and passed for local individuals, veterans and family members to their loved ones serving during Desert Shield.

## All Treats, No Tricks, in ARRL November Sweepstakes

Halloween is here, which means ARRL Sweepstakes is knocking at the door. No tricks, though, said ARRL Contest Program Manager Paul Bourque, N1SFE. "If the band conditions are as good as they were this last weekend, we're in for a real treat."

The CW weekend of ARRL Sweepstakes is November 2-3. ARRL Sweepstakes is the "oldest domestic contest, beginning in 1930," with competition at the individual, multi-operator, and school club levels.

In this contest, multipliers are the 85 ARRL and RAC Sections; each may be worked once in the contest, regardless of band. The exchange is daunting for contest first-timers, but familiar to those who have operated it before. Contacts may be made on 160, 80, 40, 20, 15, and 10 meters, but because multipliers may only be worked once, activity tends to cluster on the bands that are open and populated.

Phone weekend will be November 16 - 18.
